As part of EPC's commitment to continuous improvement, in March of 2011 we introduced the first two devices in our second generation family of eGaN FETs. The second generation devices offer significant performance improvements over the first generation devices and are environmentally friendly; being lead free, RoHS compliant (Restriction of Hazardous Substances), and halogen free.

With the release of a full family of second generation products available as of September, 2011, EPC will discontinue manufacture of the original family of eGaN FETs denoted as EPC1xxx devices.
